Utility Updates

BT Openreach

- 1. ID discussed commercial/rural build works in Arbroath, Forfar, Montrose and Broughty Ferry
- 2. ID to email JW regarding works on 24 exchanges on PKC network

3. ID aware of ongoing issues with BT Morrisons on PKC network and is going to arrange a meeting with JW to discuss.

SSEN

- 1. Mostly fault and customer driven works
- 2. Three schemes coming up in Dundee including works to Kingsway substation

Scottish Water

- 1. No upcoming works on Dundee City Council network
- 2. All Angus works are programmed on register with the exemption of one job in Montrose and DC and DP to arrange site meeting.
- 3. DP discussed the works ongoing on the A989 Tay Street, Perth due to finish December 2024, previous complaints that have come in regarding traffic signals in the area but since the traffic management has been changed the complaints have not been as frequent. JW advised the new set up is working much better and thanked Scottish Water for their help and co-operation.
- 4. DP is to liaise with CH regarding a meeting with works that are required on the A9.

AOCB

- JG mentioned inspections and joint inspections and advised that best practice was to spread Sample A inspections through the year.
- JG mentioned that some LA's had submitted their entire Sample A inspections in the first quarter, and some were between 50% and 70%
- JG advised there was a high level of D1's and D2's on declined inspections due to inspectors carrying out repeat inspections.
- JW advised that if defects were repaired as per code of practice then problems could be rectified if met on site.
- JG advised there had been issues with the inspectors App.
- JG advised that her, Fiona McInnes, and Iain Ross were working with Symology to create a report on RAUC meetings.
- CH asked that utility companies applications are accurate with correct contact information.
- ID introduced AP as Duncan's replacement, a face-to-face meeting is to be arranged with JW and AP has a teams meeting arranged with Angus Council

- JW asked for utility companies to be thorough with their noticing as there have been a few occasions where give/take has been put as traffic management type when the road is not suitable.
- JG advised that on SRWR not all options are available for working on one-way streets.
- ML suggested that maybe utilities were unaware that give/take was a form of traffic control and may see it as "all lanes open".
