Compliance Officer Standard Observations

Background

The Transport (Scotland) Act 2005, as amended by Section 110 of the Transport (Scotland) Act (2019) grants powers to “authorised persons” to carry out various inspection functions on Undertakers, Road Works Authorities and Roads Authorities. This role will generally be carried out by the Commissioner’s Compliance Officers.

Commissioner Observations

Where Compliance Officers observe a non-compliance that does not amount to a systematic failing, the option to record a Commissioner observation on the SRWR can be utilised.

In order to allow efficient review, and to establish where these form an identifiable pattern, it has been considered necessary to use a standardised list of comments when recording Commissioner Observations. Photographs evidencing these comments will also be uploaded to the SRWR. Where these detail a breach of a duty, additional information will be provided giving further context/explanation.

This approach is also considered to be helpful in allowing receiving organisations to monitor their own performance and make necessary improvements.

Appendix 1 lists the current standardised list of comments that Compliance Officers will utilise when recording Commissioner Observations.

This list will be subject to periodic review.
