### **Commissioner Advice Paper 14**

#### Performance Monitoring Framework 2025/26

This Commissioner Advice Paper sets out the list of performance indicators and targets that organisations undertaking road works activity in Scotland are expected to achieve in 2025/26. The indicators will be used as the basis for annual performance reviews and could be used by the Commissioner in assessing whether organisations have complied with their duties under the New Roads and Street Works Act 1991.

Appendix 1 provides the detailed list of performance indicators and targets for each of the individual indicators for the period 1 April 2025 to 31 March 2026.

The Commissioner issues a quarterly performance dashboard to provide a view of all organisations working on the road network. This allows transparency and aims to assist organisations to benchmark their own performance against peer groups.

The dashboard will be issued after the data is locked down in April, June, October and January of the reporting year. As previously announced, only a subset of indicators will be included in the quarterly dashboard but all of the key indicators are available through the combination reports in the Scottish Road Works Register.

Organisations are expected to have their own monitoring processes in place to ensure they meet expected targets.

Organisations are expected to contact the Commissioner's office when performance does not meet the required standards.
