7.0	Sample/Defect Inspections/Defective Apparatus VP presented a report showing current SLC Inspection Report of Outstanding Defects and Resolved Defects Aug – November 21 (as at 8 November). The report was issued in advance of meeting within the package issued with the meeting request. Tab 1 Results highlights a summary over all with individual tabs listing the outstanding defects for each utility. A tab for each utility shows a list of D2 inspections and the date of the last inspection. This is ordered on how old the defects are. Could utilities please concentrate on clearing older defects as these are being charged for follow up inspections. Some defects going back 3 or 4 years to be tied up with site meetings arranged with local NRSWA inspectors if necessary to find a resolution. VP also noted a number of Defects / Unattributable works are still with SLC channel – R. Hamilton will be contacting utilities to resolve this issue. Defects should not remain with SLC and currently 38 on the list. SLC will update the report and send out. DC reiterated SLC aim to protect the condition of the road network.
