	<p>JO welcomed everyone to the meeting. All asked to check accuracy of notes when available and advise if missed from attendance list.</p> <p>No changes to notes of 27 April 2021 and therefore accepted.</p> <p>No matters arising.</p>	<b>ALL</b>
<b>2</b>	<b>STATUTORY UNDERTAKERS PROGRAMME</b>	
<b>2.1</b>	<p><b><u>SGN</u></b></p> <p>JG noted all major projects are in the register. Any subsequent meeting with the relevant Roads Authority will be convened.</p>	
<b>2.2</b>	<p><b><u>BT / OPENREACH</u></b></p> <p>Duncan MacLennan has supplied programmes to DCC/PKC/AC.</p>	
<b>2.3</b>	<p><b><u>SSEN</u></b></p> <p>CM noted a major cable renewal scheme in Dundee between Clepington Road and Milton Street starting 23 August and lasting 5 weeks. Road closures affecting Clepington Road, Hospital Street, Strathmore Avenue and Milton Street.</p>	
<b>2.4</b>	<p><b><u>Scottish Water</u></b></p> <p>Darren Pointer had forwarded work programmes to DCC/PKC and AC. DCC involved a programme of valve renewals previously delayed.</p> <p>CC confirmed a forthcoming change in term contractor. Details will follow shortly via an official Scottish Water communication.</p>	
<b>2.5</b>	<p><b><u>Vodafone</u></b></p> <p>No representative, no programme.</p>	
<b>2.6</b>	<p><b><u>Virgin Media</u></b></p> <p>AM all work customer driven.</p>

<b>2.8</b>	<p><b><u>City Fibre</u></b></p> <p>JO noted discussions are ongoing with City Fibre to improve performance in Dundee. AF confirmed meetings are therefore taking place with their build partner over Dundee City Council concerns.</p> <p>AF highlighted the following:</p> <p>Dundee City Centre work is progressing as part of the H3G Project.</p> <p>City Fibre have one more road crossing on A90 Kingsway 9at Pitkerro Rnbt).</p> <p>City Fibre work will shortly stretch into Invergowrie and so into P&amp;K territory.</p>	
<b>3.1</b>	<p><b><u>Dundee City Council</u></b></p> <p>The following was noted for Dundee City Council.</p> <p>AB – programme of works enclosed with the minute.</p> <p>DL – Spaces for People schemes substantially complete. Broughty Ferry Road Safety work no update. Broughty Ferry Flood Prevention Scheme complete May 2022.</p> <p>The programmes for Street Lighting and Road Safety are also enclosed.</p>	
<b>3.2</b>	<p><b><u>Angus Council</u></b></p> <p>Works Programme enclosed.</p> <p>DH highlighted two schemes. Castle Street footway works in Aug 21 and carriageway works in Sept 21 on A933 at Colliston.</p> <p>DH further highlighted delays in getting materials which is affecting work schedules.</p>	
<b>3.3</b>	<p><b><u>Perth and Kinross Council</u></b></p> <p>BM confirmed the programme will be sent to Dundee City and shall be enclosed with this minute.</p> <p>BM noted a carriageway reconstruction scheme on the A93 Balmoral Road starting 21 Aug 21. Long diversion in place.</p>	

<b>3.4</b>	<p><b><u>BEAR</u></b></p> <p>LG and RN detailed forthcoming trunk road works at the following which will be included in the attached programme.</p> <p>RN also noted 5 sites on A92 DBFO between Ardownie and Slamondsmuir starting early August. Angus Council should already have been advised.</p> <p>RN highlights a contraflow planned for 16 Aug 21 lasting 3 weeks on the A90 Brechin bypass.</p> <p>Works at Swallow Roundabout no further advanced.</p>	
<b>3.5</b>	<p><b><u>Tay Road Bridge</u></b></p> <p>AH noted the following works:</p> <p>13 Sept 21 – one week – contraflow – structural investigation work.</p> <p>2023-24 – closures for resurfacing works.</p>	
<b>4</b>	<p><b><u>Local and Seasonal Events</u></b></p> <p>.Dundee – no major events planned.</p> <p>Angus – Ladies British Open at Carnoustie 16-23 Aug 21. Forfar 10k Run 15 Aug 21.</p> <p>P&amp;K – ETAP Cycle race still to be confirmed.</p>	
<b>5</b>	<p><b><u>SRWR / SYMOLOGY</u></b></p> <p>DM highlighted an issue Network Rail had with some work conflicts not registering on the system whilst others did. LH suggested he speak to Iain Ross to clear discuss the matter. JG also noted that a recent Aurora webinar covered the topic and details in there may address the problem.</p> <p>JG asked RA's to keep on top of declined inspections. SGN had cause to speak to a number of RA's with a view to clearing historic declined inspections against them.</p>	
<b>7</b>	<p><b><u>Reinstatements</u></b></p> <p>CC keen to have feedback form the recent alternative material trial proposed. CH to co-ordinate respond.</p> <p>CC also reiterated DH concerns regarding delays in sourcing materials. CC was concerned this has the potential to become</p>	<b>CH</b>

	and issue for the while SRWR community. LH recognised this possibility and was open to the future need for late starts/extensions due to the issue.	
<b>8</b>	<b><u>Inspections</u></b>  No major issues raised.	
<b>9</b>	<b><u>Health and Safety</u></b>  JO noted ongoing discussions with City Fibre.  CC and JG highlighted visits from HSE in relation to social distancing regulations being met on site. These visits are now diminishing.	
<b>10.</b>	<b><u>AOCB</u></b>  Currently there is no Co-chair for Tayforth with potential to become Chair in 2022 subject to Tayforth RAUC still in place. JO asked for one of the Statutory Undertakers to come forward even as an interim basis. Further meeting to take place with RAUCs members to discuss the proposed reduction from 5no RAUCs Areas to 4no RAUCs Areas with Tayforth to be split across new RAUCs Areas.  JO reminded all RAs and SU to comply with Covid restrictions for site operations
