Previous Minutes

Spen had seen an improvement in Roads Inspectors including photographs in defective apparatus reports, however, they are asking for the inspectors to be reminded and to have 2 pictures, one of location and one of manhole etc.

Matters Arising:

Colin Boyle GCC drew attention to the upcoming closure of Aurs Road in East Renfrewshire, it is from 5 June 2023 for a year and Stewarton Road, Nitshill Road, Parkhouse Road, Glasgow Road and the Hurlet will be used as a diversion route. GCC do not want any works on these roads due to the expected increase in traffic.

Thornliebank Road future Road Closure for bridge works discussions between GCC and Network Rail regards programming will start soon. CB pointed out Nitshill Road will confict. Shield Road, Road Closure for bridge renewal discussions underway with CB. David Murdoch requires extension to Darnley Road and Moray Place SRWR notices.

Fiona McInnes Scottish Water requires permission for Lane Closure for 2 manholes to be repaired Neil Forrester GCC will arrange. Problem with SRWR notice on the boundary of Glasgow and East Dumbartonshire NF will investigate.

Issue with SRWR Gazetteer, since September 2022 some street have the wrong Road Type FM has apparently emailed Calum Stewart GCC to investigate. Examples are Paisley Road West and Great Western Road shown as Type 4 roads – both should be Type 1 roads.

Owen Harte, Virgin Media stated that Virgin Media will commence operations in Blackhill he will liaise NF of GCC.

Stephen Scanlon of BT spoke of questions that they had regarding enforcing TTROs and TTRNs he is currently dealing with Calum Stewart of GCC.

Julie Greig, SGN asked about declined inspections from 2020 until now and is wanting to remove them. She will email Calum Stewart of GCC.

Fiona McInnes (Scottish Water) would like this reiterated: During GCC resurfacing valves are getting buried and tobies are getting blocked. Resurfacing to take better care to avoid this. Also ensure that snagging of work includes manholes as Scottish Water are getting defective manholes reported to them just after the maintenance period of the resurfacing has expired. Maintenance and contracts to be reminded that SW will provide new manhole covers for any that are needing replaced during resurfacing. SW may have to consider recharging the council for these types of failures.
