# 1. Introduction and Apologies

# 2. Minutes of Meeting of 7th March 2018

#### 3. Presentation – Scottish Street Gazetteer Conventions

Martin Polland welcomed Alex Ramage (Transport Scotland), who is currently the Interim Chair of the Gazetteer Group, to the meeting and invited him to give his presentation on the above subject.

Alex Ramage gave the presentation as follows: -

- BS7666 is being reviewed to deal with Spatial Data sets for geographic referencing
- Geoplace Ltd involved because of their experience in making significant changes to the England and Wales document.
- Make the documents easily understandable for a new Custodian
- Where changes are made they are brought in as optional but identified that they will become mandatory in time
- Bringing Advice Note 5 into the main conventions document including Street Polygons Conventions

Examples of changes are: -

- Defining exactly when a record should be in the Gazetteer and when it should not.
- ESU id, for new ESU will be based on the 4 digit custodian code, with a incrementing number for that custodian. (Guaranteed unique)
- There will be an additional Island attribute to allow better addressing for Gazetteer users on the Islands e.g. Shetland.
- To provide additional support, Improvement Service have appointed a "Street Gazetteer" officer.

# **Document Ownership**

- One Scotland Gazetteer Conventions are owned by Improvement Service and they look after the Address Gazetteer Standards
- Chapter 12 onwards are owned by the Street Gazetteer Community through the RAUC(S) Gazetteer Group

#### Consultation

- Consultation will include the software Manufacturers, Local Authorities and RAUC(S)
- The document is almost ready to be passed to the Gazetteer Group in October and to the Community in November.

- It is planned that the revised / final document will be prepared by January.
- The Document will be submitted to RAUC(S) in March for their approval.

Other comments

- RAUC(S) need to be involved as the Gazetteer is the basis of the Register.
- The Highway Data Set will be open data.

# a. National Coring Programme

# 5. Area RAUC(s) Action Reports

#### a. NoSRAUC Area

No issues remitted to this meeting.

## b. South East Area RAUC

A.H. reported that East Lothian were being pressured to allow slot cutting to lay fibre optic cables in the road in Gifford and RAUC(S) were being asked for a formal response to support their case.

Comment was made as follows: -

- The view was that the process did not meet the requirements of the SROR.
- This was based on the difficulty to reinstate and for the maintenance of the road and other S.U. apparatus in the future.
- The photographs circulated indicated that the work was being carried out on a low category road.
- A Scottish Government Consultation on narrow trenching will be issued in the near future. All should make a response when it is circulated.
- The plant needs to be below the construction layers or it is very likely to be damaged by maintenance even for patching.
- There have been problems before on sites where an agreement has been made on maintenance but when the responsible parties changed the agreement was dropped leaving others with the problems of maintenance and damage to plant.
- There was no doubt that this was a quick efficient process, but it still needed to meet the requirements of the Code.
- RAUC(S) could only indicate that any process which was out with Codes or Specifications was not permissible.
- If there was a trial it would have to prove that it could meet the Codes.

Rope and Cone Traffic Management

Scottish Water and Edinburgh City Council had been unable to come to an agreement on this matter and RAUC(S) were being asked to set up a Dispute Panel.

The following decision was agreed by the Committee: -

• The two parties were asked to send reports as soon as possible to the Co-Chairs who would review them and decide if they considered the matter to be a complex dispute or if not refer it back to the Area to set up a Dispute Panel.

#### c. South West Area RAUC

No issues remitted to this meeting.

## d. TayForth Area RAUC

S.W. reported that Angus, Dundee and Perth & Kinross had amalgamated to hold one Local Meeting rather that the 3 meetings. The attendance had been poor at the two meetings so far, but the decision was to hold one more amalgamated meeting but revert to the 3 meeting format if there was no improvement. S.Us were asked to note this arrangement.

# e. WOS Area RAUC

The following three topics were commented on: -

## Section 109 Sites

 A site in the WoS area had been excavated pending the provision of a Scottish Water connection. No Section 109 permit had been issued and there was no signing, lighting and guarding. The request was made for Scottish Water to be more proactive in these instances and to ensure the permit was in place and where the site was not properly protected the information was passed to the R.A.

Commissioner's Statistics – Zero Tolerance Reports

# 8. Standing Reports

# a. The Scottish Road Works Commissioner's Report

The previously circulated Bulletin was taken as read with the following comments: -

- The closing date for the payment of the Prescribed Fees was the 2<sup>nd</sup> June. Reminders were sent out and all fees eventually collected.
- All Organisations should submit their comments on the draft Transport Bill to the Scottish Government by the 27<sup>th</sup> September.
- The Performance Reviews will be issued in the next two weeks. They are shorter than in previous years and should be easier to read and understand. All Organisations with poor performance must respond as requested in their Review.

Red, amber, green is used to indicate the level of performance.

- Tim Masters has retired, and his post has been filled by Jim Clegg. Jim will work on the coring programme (coordination and collation), the Bill and the Permits and Licencing Module amongst other matters which are required.
- All Organisations should have moved over to the new domains as the old domains will be closed later in September. If there are internal IT problems I.R. can offer assistance.

- The Mobile Apps were commented as follows; The Works Promoter and VAULT Apps are now operating on all platforms
  - The VAULT App will be issued on all Platforms in October / November
- The Street Manager Development has a budget of £10 Million to provide a Register for England and Wales.
- Fibre Toolkit A letter has been sent out to the Chief Executives in Scotland. As indicated above it is, in its present form, unfit for use in Scotland. There is reference to the use of Permits which the Scottish Community generally considers unnecessary for use in Scotland where the performance on Noticing provides a standard in excess of that predicted in England using permits. The Scottish Community is also looking to improve on its current performance.

K.Q has already produced a draft document which could be used in Scotland but would need the approval of the Community.

Scotland needs to work with the Department for Culture, Media, and Sport to roll out Broadband in Scotland, but the method needs to fit with the existing Scottish Legislation, Codes, Advice Notes, Co-ordination and above all Co-operation.

- Development, all be it at a slower rate, is continuing on the web site. Diary transfer will be provided as budget allows.
- There is interest in some areas in introducing Permits. If you do not want this development in the Scottish Legislation you must inform the Scottish Government via the response to the Draft Bill. The Commissioner pressed all Organisations to submit their responses to the Scottish Government as soon as possible as the closing date for responding is 27<sup>th</sup> September 2018.

# ci) Quarterly Management Report (Includes Vault Update Report and Gazetteer Update Report)

- The Fees for 2018/19 have all been collected but some Organisations were late in making their payment.
- Some Organisations are not making their payment for training in the required period. Action will be taken to deal with this problem.
- If Operatives need access to the Apps an application need to be made to Symology.
- SAT are working with Symology on the development of Aurora. Any suggestions for improving the service should be submitted to SAT in a Change Request.
- There are several Organisations indicated in Yellow on the Gazetteer upload report. They should be preparing an Upload and submitting it sooner than later.

### d. Electric Vehicle On-Street Charging

With the increasing numbers of electric vehicles on the road the pressure is going to increase on R.As to deal with the provision of charging facilities.

It was noted that the supply available from street lighting systems is not sufficient to accommodate vehicle charging.

SPEN indicated that they are already investigating solutions to this requirement.

Information on methods of provision and developments should be shared round the Community as all are face with increasing numbers of requests for facilities.
