#### 4. RAUC(s) Working Group Reports

#### a. National Coring Programme

The Committee noted that:-

- The Advice Note No. 3 was revised as requested and has now been published on the Web Site.
- The Timetable for the programme is on Page No. 2 of the Advice Note.
- All S.Us and R.As should have appointed their Programme Contacts and have passed their details to the Lead R.A. in the Areas.
- S.Us can ask to see and approve the Accreditation details of the proposed Contractor before the appointment is made.
- Transport Scotland and Western Islands Council will be taking part in the programme.
- Shetland and Orkney are not taking part in the programme.
- The one outstanding Tender should be issued on quick quote by the beginning of April with a mid-April return.
- R.Mack. asked Openreach to pass details of their Coring Contact for the WoS Area to him as soon as possible.
- As previously indicated, as soon as one phase of the programme is completed the next should follow on.
- The Coring Site Sample Report will be issued in the first week of April. The R.A should prepare and mark out their proposed sites (with if possible second choice sites) within two

weeks so that they can be inspected by the S.Us. A month is allowed to agree the final programme.

## 5. Area RAUC(s) Action Reports

a. NoSRAUC Area

The following issues were discussed: -

- The level at which plant should be laid in the verge. The view was that the depth should be measured from the adjacent road level to give the plant protection from the possibility or lowering the verge or cutting grips across it. This matter will be considered by the SROR Working Group. Action- K.S. / A.B.
- National Coring as above.
- The Police have indicated that they will attend the August meeting in Inverness to comment on road safety issues at Road Works.
- Some concern had been expressed about the use of the Apps in the Rural areas covered by NoSRAUC.
- b. South East Area RAUC

The following issue was discussed: -

• R.As were now coring prospective sites to check for the presence of coal tar material. Where it was being located it was being recorded as engineering difficulty ion the Register.

The committee agreed that it was not the right time to invite SEPA to attend a RAUC(S) meeting.

Funding was being sought to allow research into a more accurate test for Coal Tar as the existing test is not reliable.

It was likely that the volatiles in the material will have reduced and there was no evidence that it would affect health. Due to it being used widely in resurfacing it is likely to be found extensively in the road construction.

M.P. will keep the Community advised on progress on this topic.

#### 6. RAUC(s) Business

#### a. Safety - Issues for Consideration

The previously circulated paper on the placing of a needle on the seat of a mini digger on a SGN site was commented on as follows.

- The needle was placed on the seat in such a way that it would have pierced the driver if he had sat on the seat.
- M.P. indicated that he would circulate the paper to SCOTS. Action M.P.

## **b.** Improvement Notices

The previously circulated Action Tracking summary was taken as read and comments were made as follows: -

Edinburgh City is due to close the SGN Improvement Notice but the performance of the other S.Us which still had outstanding Notices was still below par. The details of the performance was provided in the attached schedule.

West Lothian still had an outstanding Notice issued against Openreach for poor reinstatements.

Mid Lothian had now cleared their Notices.

## d. Remits from SRWR Steering Group

The SRWR Steering Group agreed that the sample CAT A and CAT B reinstatement inspections would be fully issued by 4<sup>th</sup> March. This would help the R.As to complete their allocation by the end of March.

## 7. HAUC (UK) and Associated Sub Group Reports

#### a. Report

The last meeting was held in January. D.C. reported on Items which had been discussed and were of interest to RAUC(S) as follows: -

- The Red Book would be reviewed to check if there was any content which required to be revised.
- The Infrastructure Committee would be reviewing road adoption procedures. J.D. would represent Scotland on this Group.
- The Diversionary Works Code will be reviewed.
- Electric Vehicle Charging Points is an increasing issue and advice needs to be prepared.
- District Heating Schemes is an increasing issue and needs to be considered. The providers do not have Code Powers.
- The Street Works UK and Adept are considering the problems associated with Coal Tar materials in the road construction. M.P. will contact these Groups and check what actions they are taking.
   Action M.P.
- The SROH was published today and there will be an 8-week consultation.

#### ai. Convention Update

The Convention promises to be a good event and there are already 200 applications for passes to attend. The number of trade stands has increased from last year.

## aii. The Street Manager Project

This development is ongoing, and comment was made as follows: -

- It is likely that Street Manager will be rolled out in August.
- The DfT has funding for an additional 3 months of development.
- It is possible that the system may not provide as many facilities as required.

• The plan is for all to be on Street Manager by 20/20 with the facility provided to administer Permits.

#### 8. Standing Reports

## a. The Scottish Road Works Commissioner's Report

The previously circulated Bulletin was taken as read with the following comments: -

- The Commissioner has been informed that the regulations required for the 2019 Invoices for
  Prescribed Fees and Amounts may be delayed which is likely to lead to a reduction in the
  time allowed for payment from 60 days to maybe 30 days. All should be prepared to make the
  payment within the reduced period. By the 1<sup>st</sup> April I.R. will have details of the individual
  Fees which will be invoiced. Organisations should check with I.R. in order that they have
  their payments ready.
- The SRWR Steering Group are reviewing options for training on Aurora. The current proposal includes seminars for managers/infrequent users of the SRWR, classroom training for SRWR Super Users and an option for online courses (Computer Based Training) for the remaining users. The training will be available prior to the roll out of Aurora in April 2020.
- SRWR Super User Events to view the current development of Project Aurora were held on 12-15 February. The events were well attended, and an additional date was added. The response from the Community has been very positive.
- The SRWR Mobile App for Inspectors has taken longer to test and develop than expected. It is now due for roll out on 1<sup>st</sup> April. The App includes the facility to record non-referenced inspections.

- The SRWR reports have now been released on the SRWR live site. This includes the ability for each organisation to download their performance review data sheet directly from the Register.
- The Commissioners Annual Report 2017/18 has now been published.
- N.B. has now moved to her new post with UK Statistics. The new member of staff (Graham Milne) has been appointed and will join the section in due course.
- J.D. is dealing with the Improvement Plans requested from some Organisations post the Annual Performance Review.
- All should remember to send comment to the OSRWC when they have poor performance in the Quarterly Reports.
- The request was made for the reports to be unlocked so that they can be viewed in Excel.

## **b.** Policy Development Group

K.Q. commented on the Scottish Government matters as follows: -

- Fees and Amounts as above. The problem of the delay should only affect this year.
- The Transport Bill is in currently in Phase 2. The interest in work space parking charges may result in some delay.
- The Ministers are reviewing the results report on the Narrow Trenching Consultation.

- The Validation Process will be more exacting.
